1 Briefly describe the organization's mission: We seek to improve the lives of companion animals and to solve the problem of pet overpopulation in the Espanola Valley by providing humane shelter for cats and dogs, facilitating their adoption and offering spay-neuter, humane education, and other progressive animal welfare programs.

4a (Code: ) (Expenses \$ 872,107 including grants of \$ ) (Revenue \$ 382,890 ) Clinic- Espanola Humane operates a spay/neuter clinic that offers free surgeries and vaccinations to pets of area residents, which results in 6,100 spay/neuter surgeries and over 15,000 vaccinations every year. The goal is to reduce the number of unwanted animals and create a healthier community for pets, their families and their neighbors.

4b (Code: ) (Expenses \$ 948,063 including grants of \$ ) (Revenue \$ 249,755 ) Shelter - Espanola Humane also manages a municipal shelter that receives 3,000 animals each year. The shelter welcomes every animal, including the very elderly, ill, aggressive or injured. Many animals are not able to be rehomed but Espanola Humane proudly adopts out 84% of these at-risk pets. Since the shelter is owned by the city, Espanola Humane has very little overhead and 89% of donations go directly to animal care.

4c (Code: ) (Expenses \$ 492,761 including grants of \$ ) (Revenue \$ 8,094 ) Thrift Stores - To support the mission, Espanola Humane operates two resale stores in Santa Fe, NM. The Barkin Boutique features high-end clothing, jewelry, shoes and handbags, while the Barkin Attic specializes in furniture, art and collectibles. Both stores accept donations of new and gently used items and the Barkin Attic has a team who picks up estate and large furniture.
