Clinic - Espanola Humane operates a spay/neuter clinic that offers free surgeries and vaccinations to pets of area residents, which results in 5,300 spay/neuter surgeries and over 14,000 vaccinations every year. The goal is to reduce the number of unwanted animals and create a healthier community for pets, their families and their neighbors.

Shelter - Espanola Humane also manages a municipal shelter that receives 3,000 animals each year. The shelter welcomes every animal, including the very elderly, ill, aggressive or injured. Many animals are not able to be rehomed but Espanola Humane proudly adopts out 91% of these at-risk pets. Since the shelter is owned by the city, Espanola Humane has very little overhead and 90% of donations go directly to animal care.
